WSA Membership Rules & Regulations

RECITALS

WHEREAS, the WSA sanctions events, promotes events & athletes, and provides support for charities worldwide.

WHEREAS, Professional Athlete desires to join to support and receive benefits from the WSA.

NOW THEREFORE, in consideration of the mutual promises hereinafter set forth, the parties agree as follows:

1. **Membership.** Subject to the terms and conditions hereinafter set forth, the WSA grants Professional Athlete membership into the WSA pursuant to the qualifying standards as set forth by the WSA Board of Directors. Professional Athlete agrees to abide by the WSA Code of Conduct, Code of Ethics, Operating Policies, and Dress Code, as may be amended from time to time. WSA may at anytime cancel membership of any WSA Professional Athlete for any reason.

2. **Term of Contract.** The term of this membership agreement is one-year from the date of execution and will automatically renew annually unless Professional Athlete notifies WSA in writing at least 30 days in advance of his/her intention not to renew said agreement.

3. Functions of the WSA: It is the function of the WSA to promote all athletes in all sports recognized by the WSA.

The WSA, with the unity of its membership, shall make its best effort to ensure the following:

The **World Sports Alumni** functions:

1. **Uniting ALL Professional Athletes from ALL Sports. GLOBALLY.**
2. Creating synergy between athletes and the sports they represent.
3. As a unified force of all sports, the WSA will become a larger voice to exact Change & IMPACT.
4. Promote & market athletes.
5. Help assist in achieving goals, initiatives, projects for pro athletes within the alumni
6. Book athletes for appearances, endorsements, & speaking engagements.
7. Produce WSA events.
8. Assist and contribute to help former athletes in need.
9. Assist and contribute to charities.
10. Sanction amateur & pro events. Sports or sports related.
11. To overall better the lives of pro athletes.

4. Sanctioned Events & Competition. Professional Athlete agrees to support WSA produced or sanctioned events when convenient to their personal schedule.

5. Media and Marketing Rights.

a. For and in consideration of the mutual covenants and promises herein contained, Professional Athlete hereby grants to the WSA the non-exclusive right and permission to copyright, use, reuse, publish, broadcast, republish and rebroadcast the athlete's appearances and likeness in WSA events, media and marketing.

b. The WSA shall also create and design such trademarks, service marks, logos, graphics, and other symbols to be utilized in identifying the WSA and to obtain public and media recognition of WSA and its events.

6. Indemnification. Professional Athlete hereby agrees to indemnify the WSA and hold the WSA harmless from and against any and all claims, damages, costs, expenses, fees (including attorneys' fees) incurred by the WSA arising from, in connection with or related to, this Agreement. Professional Athlete also expressly understands and agrees that the WSA, its sponsors and host sites, and its Officers and employees shall not be liable for any direct, indirect, incidental, special, consequential or exemplary damages resulting from athlete's membership in the WSA or participation in any events of the WSA.

7. Other Terms. This Agreement shall be governed and construed in accordance with the laws of the state of Florida.

8. Termination. This Agreement may be terminated by mutual consent of the parties hereto or by a material breach by either party at anytime. The WSA may terminate this Agreement for cause in the event that Player engages in dishonest conduct, illegal use of drugs, or violations of the current Code of Conduct, Code of Ethics or Player engages in conduct that reflects adversely on the WSA.
